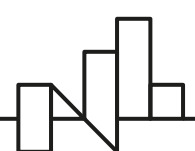

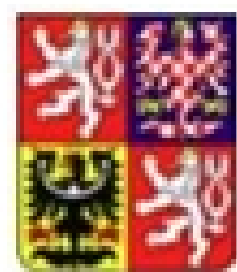

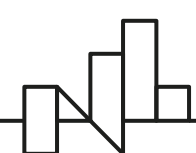

Integrity and accountability of the public administration



Public administration

- Improved responsiveness of the public administration to citizens' needs
 - PDP 1 - Improvement of preconditions for decentralization and availability of public administration in the territory
 - PDP 2 - Evaluation of the public administration performance in the Czech Republic and recommendations for the further strategic development
 - **SGS – Involvement of the public in the decision-making processes**



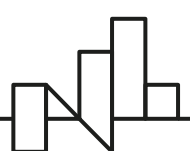
Fight against corruption

- Accountability of public administration improved
 - PDP 3 - Strengthening public financial management and control
 - PDP 5 - Strengthening the Fight against Corruption by Increasing General Awareness of the Public Sector Focusing on Judges, Prosecutors and Public Administration



Anti-money laundering

- Performance of the Police of the Czech Republic in detecting cases of money-laundering, corruption and terrorist financing increased
 - PDP 4 - Deepening of the professional qualification of the law enforcement authorities in the field of the fight against corruption, money laundering and terrorism financing

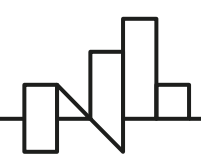


The Small Grant Scheme



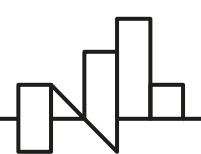
Small Grant Scheme Call

- Expected launch 2Q 2021
- Mandatory donor project partnership
- Objective: to ensure quality public administration that is open, transparent, accountable to the public, efficient, and enables public participation in decision-making processes



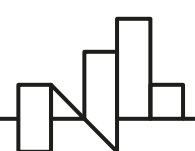
Eligible activities

1. motivation to participate
2. promotion of active citizenship
3. increasing the professional qualification
4. pilot testing of various forms of communication
5. building mutual trust
6. support of formal and/or informal forms of public involvement
7. focus on gender aspect



Areas of supported activities

1. Training and development of public administration employees and elected representatives in the field of civic participation
2. Training of the public
3. Passive methods of participation - information
4. Tools of active communication with the public

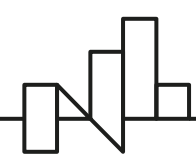


Eligible applicants

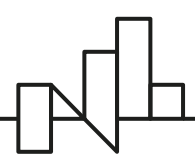

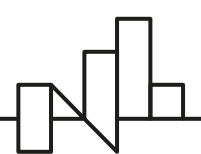
Allocation and grants

- Allocation of the Call is 500 000 EUR (may be increased)
- Minimum grant applied for 50 000 EUR
- Maximum grant applied for 200 000 EUR
- 100 % grant (covers partnership costs too)



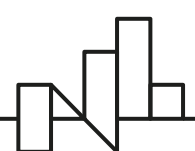
Eligibility of expenditures

- Examples of eligible expenditures:
 - the cost of staff assigned to the project
 - travel and subsistence allowances
 - cost of equipment
 - costs of consumables and supplies
 - costs entailed by other contracts awarded
- Costs will be eligible in accordance with chapter 8 of the Regulation available on the PO's [website](#)

How to find a partner

- To raise your chances to find a donor project partner:
 - Focus on a specific topic and define the challenge clearly
 - Define how the foreign input is expected to give added value to the project
 - Discuss mutual expectations for the collaboration
 - Make sure that the goals and responsibilities are clearly defined to all parties
 - Discuss the budget and timelines together
 - Spend time together and build mutual trust
 - Be enthusiastic
